**Topic:** CAS2Net 2.0 – 1.18.1 Release Notes

**Discussion:** AcqDemo PMO and ALTESS continue to improve system performance and incorporate enhancements into CAS2Net. The following are hotfixes were released effective 10/08/2019 @1800.

### **Story – New functionality**

- CAS-1548 - As a Supervisor I want to create a Closeout for the Previous Fiscal Year
  - As a supervisor I need to create a closeout that occurred before the start of the new Fiscal Year
- CAS-1549 - As a Supervisor I want to create a CP, MP, or AA for the previous Fiscal Year
  - As a supervisor I need to create a Contribution Plan, Mid-Point Assessment, or Annual Assessment that occurred before the start of the new Fiscal Year

### **Improvement – Function Enhancement**

- CAS-1555 - Hot Fix: Manager Offline Interface Access
  - Given: I am a Manager
    - Action: I click on Manager on the left menu
      - Result: I no longer see the Offline Interface option

### **Bug – Issue with code in the system**

- CAS-1536 - 2019 Midpoint Assessment
  - Given: I am employee on October 1, 2019
    - Action: I click on Mid-Point Assessment in the Employee Menu
      - Result: I should be able to select the year to view the Mid-Point Assessment for 2019. (System now reports that I do not have an approved Contribution Plan)
- CAS-1550 - Hot Fix: Discrepancy Report Performance Issues
  - Employee data report needs optimization to reduce time to completion.
  - The report can't time out before completing the report for a reasonably sized request (all fields, around 15 pay pools)
- CAS-1554 - FY19 Closeouts Are Inaccessible (HOT FIX)
  - Given: I am an Employee who has an FY19 Closeout in Draft
    - Action: I expand the Employee menu
      - Result: I see the Closeout Assessment menu item, so I can complete my FY19 Draft Closeout
- CAS-1556 - Hot Fix: Expected OCS on 2020 Contribution Plans
  - 2020 Contribution Plans should have an EOCS, and Range of 0-0-0 until we turn the database in January.
- CAS-1557 - Hot Fix: Expected OCS on Current Settings - Employee Data Report
  - Current Settings - Employee Data Report should have an EOCS, and Range of 0-0-0 until we turn the database in January.

- CAS-1559 - Hot Fix: CCAS Results for Previous Year Report - Formula for Delta Score is incorrect
  - CCAS Results for Previous Years formula for Delta score is incorrect.
  - Description: The CCAS History Report shows the past and current proposed scores. Thank you for this update as we proceed with CCAS FY19 activities. However, looks like the delta scores are computing in the wrong direction. If an employee's EOCS is 75 but the recommended score is a 76, the delta is computing a -1. There may be a glitch with the formula.
- CAS-1561 - Hot Fix: Plans and Assessments Fiscal Year Workflow
  - Given: I am an employee
    - Action: I access a contribution plan from the employee menu
      - Result:
        - If there is an item for the current performance year
          - Load the item relevant to the performance year.
        - If there is an item for the next performance year
          - Load the item relevant to the next performance year fiscal year.
        - If the employee start date is prior to the presumptive status date for the performance year
          - Load the item relevant to the performance year fiscal year creating it if necessary.
        - If the employee start date is after the presumptive status date for the performance year
          - Load the item relevant to the next performance year creating it if necessary
          - Do not include the performance year in the fiscal year drop down unless there is an item for that year
        - If the current date is after the presumptive status date for the current performance year
          - Include the next performance year in the fiscal year drop down
    - Given: I am an employee
      - Action: I access a midpoint assessment from the employee menu
        - Result:
          - If there is an item for the current performance year
            - Load the item relevant to the performance year.
          - If there is an item for the next performance year
            - Load the item relevant to the next performance year fiscal year.
          - If the employee start date is prior to the presumptive status date for the performance year
            - Load the item relevant to the performance year fiscal year creating it if necessary.
          - If the employee start date is after the presumptive status date for the performance year
            - Load the item relevant to the next performance year creating it if necessary
            - Do not include the performance year in the fiscal year drop down unless there is an item for that year

If the current date is after the presumptive status date for the current performance year

Include the next performance year in the fiscal year drop down

- Given: I am an employee
  - Action: I access an annual assessment from the employee menu
    - Result:  
Load the item relevant to the performance year fiscal year creating it if necessary.  
If the current date is after the presumptive status date for the current performance year  
Include the next performance year in the fiscal year drop down
- Given: I am an employee
  - Action: I access a closeout assessment from the employee menu
    - Result:  
Load the most recent closeout or the a list of closeouts for the fiscal year of the most recent closeout
- Given: I am a supervisor 1
  - Action: I access contribution plans, midpoint assessments, annual assessments, or closeouts from the supervisor menu
    - Result:  
Include the performance year in the fiscal year drop down  
If the current date is after the presumptive status date for the current performance year  
Include the next performance year in the fiscal year drop down  
Allow creating items for both performance year and next performance year (if available)  
If attempting to create an item for performance year when that is not allowed  
Redirect to next performance year
- CAS-1572 - Administrator - Previous Cycle Data vs Current Profile Report Performance Issues
  - Administrator - Previous Cycle Data vs Current Profile Report needs optimization to reduce time to completion.
