


2023 End of Cycle

- Macro-based CMS will be used

- Macro-free CMS will be piloted with a few pay pools
- Final upload will be from the Macro-based CMS


Why macro-free CCAS spreadsheets?

The DoD STIGs (Security Technical Implementation Guide) states macros that are not digitally signed by a trusted source are supposed to be **blocked**, this has been the case for awhile now, it is not new. This is because VBA macros are a common way for malicious actors to gain access to deploy malware and ransomware thus DoD wants those to be from trusted sources, thus the reason the STIGS say to block them if they are not signed. *[CCAS Sub-Panel Meeting Spreadsheet, CMS, and PAT have VBA macros.]*

Microsoft in 2022 stated they were going to start blocking macros by default, they started rolling that out but then pulled it back after some feedback from users. They may decide to roll this out in some modified version in the future, like still allowing trusted macros to run but block macros from unverified/trusted sources. This would align closely to what DoD has been doing for some time with restricting macros to those that are digitally signed by a trusted source.
